Note: The candidates must check his/her eligibility before applying for the course.

**Refund Rule:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission. <b>(on &amp; before 7<sup>th</sup> September'2020)</b>
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission. <b>(8<sup>th</sup> September to 23<sup>rd</sup> September'2020)</b>
(3)	80%	15 days or less <b>after</b> the formally notified last date of admission. <b>(24<sup>th</sup> September to 8<sup>th</sup> October'2020)</b>
(4)	50%	30 days or less, but more than 15 days, after formally notified last of admission <b>(9<sup>th</sup> October to 23<sup>rd</sup> October'2020)</b>
(5)	00%	More than 30 days <b>after</b> formally notified last date of admission. <b>(24<sup>th</sup> October'2020 onwards)</b>

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: 1) The above refund rules are as per University Grants Commission (UGC) notification on Refund Of Fees and Non Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable).
