#### **Refund Rules:**

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission (on or before 01st July'2020)
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission. <b>(02</b> <sup>nd</sup> <b>July to 17</b> <sup>th</sup> <b>July'2020)</b>
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission. (18 <sup>th</sup> July to 01 <sup>st</sup> August'2020)
(4)		30 days or less, but more than 15days, after formally-notified last date of
	50%	admission. (02 <sup>nd</sup> August to 16 <sup>th</sup> August'2020)
(5)		More than 30 days after formally-notified last date of admission.
	00%	( 17 <sup>th</sup> August'2020 onwards)

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
